- Participants agree to abide by the rules of Northern Stars Gymnastic Club.
- Parents are solely responsible to ensure their children are picked up following scheduled classes.
- Club reserves the right to change/combine/cancel classes due to enrollment.
- No refunds/credits/make-up classes can be provided due to your child's absence.
- Upon receipt of doctor's note, class credit may be provided (no refunds) for extended illness or injury (missing 2 or more consecutive classes). Consideration shall be given to extraordinary circumstances affecting child's attendance.
- Each participant is required to pay annual \$30.00 fee (July2010-June2011) for Gymnastics ON & administration fee.
- There will be no make-up for classes cancelled due to weather conditions.
- \$30.00 fee shall be charged for each N.S.F. cheque.

Refund Policy

- All transfer/ refunds / credits are subject to a \$20.00 administration fee.
- Minimum five (5) days written notice is required to withdraw before the start of program. All refund subject to \$20 administration fee. If written notice is submitted less than five (5) days prior to the 1st class, the refund will be subject to the admin fee and cost of the 1st class.
